The Northwest Florida Water Management District is pleased to provide the Five-Year Water Resource Development Work Program required by Chapter 373.536(6)(a)4, Florida Statutes. The Fiscal Year 2008-2009 Update may be found on the District's web site at www.nwfwmd.state.fl.us/pubs/wrdwp/wrdwp.html. If desired, we can also forward the report to you in hard copy or on CD.

The Five-Year Water Resource Development Work Program provides a description of activities and the funding budgeted to continue implementing the District's regional water supply plans. Plans have previously been developed for Region II, covering Santa Rosa, Okaloosa and Walton counties, and Region V, covering Gulf and Franklin counties. Added this year are budgeted activities to implement the Region III Regional Water Supply Plan for Bay County, approved by the Governing Board in August 2008. Significant water supply development assistance activities in these and other regions of the District are also described.

This report is preliminary and figures may be revised after year-end financial statements are completed. The final report will be included in the Consolidated Annual Report, due March 1, 2009.
