RESOLUTION 2009-04

A RESOLUTION OF THE CITY OF CHATTAHOOCHEE, FLORIDA DESCRIBING AND NOMINATING A BOUNDARY AMENDMENT FOR THE GADSDEN COUNTY ENTERPRISE ZONE

WHEREAS, Chapter 2005-287, Laws of the State of Florida, the Florida Enterprise Zone Act, requires that a resolution be passed requesting changes in the boundary of the enterprise zone by the local government submitting an application for re-designation of the enterprise zone to the State and explaining the reasons and conditions for which the Enterprise Zone merits re-designation, and

WHEREAS, the boundary changes are necessary to continue to provide the most appropriate areas of Chattahoochee and Gadsden County to participate in the Florida Enterprise Zone Program, until December 31, 2015, and

WHEREAS, the City of Chattahoochee, Florida Enterprise Zone has been a proven economic benefit to the residents of the city, and therefore merits a boundary change re-designation.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Chattahoochee, Florida, that:

1. The City Council of the City of Chattahoochee, Florida finds that the boundary change re-designation is necessary for the continued participation in the Florida Enterprise Zone Program, until its current expiration on December 31, 2015.
2. The City Council of the City of Chattahoochee, Florida adopts this resolution in compliance with Chapter 2005-287, Florida Statutes, Florida Enterprise Zone Act, to nominate for boundary change re-designation of the Gadsden County Enterprise Zone, the area to be referenced by the Gadsden County Resolution which will have attached a copy of the map

reflecting the re-designated boundary zone and further incorporates as part of this resolution pages 1 thru 52 which include the legal description of the area known as the "2008 Enterprise Zone – Chattahoochee, Florida"

3. The City Council of the City of Chattahoochee, Florida finds that the Gadsden County Enterprise Zone boundary change merits re-designation given the area remains in need of economic and social revitalization.
4. The City Council of the City of Chattahoochee, Florida finds that the Gadsden County Enterprise Zone boundary change merits re-designation based on its proven economic benefits
5. This resolution shall be effective upon adoption and an original copy will be furnished the Gadsden County Board of Commissioners for inclusion as part of the Gadsden County application for boundary change re-designation of the Gadsden County Enterprise Zone.
