### **Statement of Issue:**

This item seeks approval to accept into the proper accounts reimbursement money subsequent to Public Assistance resultant from Hurricane Dennis from Federal Emergency Management Agency (FEMA).

### **Background:**

Subsequent to Hurricane Dennis, Gadsden County did sustain damage that resulted in eligibility from FEMA for Public Assistance reimbursement in the amount of \$142,109.06.

### **Analysis**

In accordance with FEMA Declaration FEMA-1595-DR-FL there were 5 small (less than \$50,000) and 1 large (greater than \$50,000) projects that resulted from either protective measures or road reparations, all subsequent to Hurricane Dennis disaster period July 7, 2005 through July 20, 2005. These projects met criteria in accordance with the Stafford Act, 44 CFR 206.201(B) and 206.225 Public Assistance Guide, FEMA 322, pages 47-52.

### **Fiscal Impact:**

The amount reimbursed \$142,109.06 equates to the federal government's 75% obligation under the Stafford Act and the State of Florida's reimbursement share of 25%. This reimbursement is to be transferred in accordance with warrant specifications that detailed the projects that received the final inspection and approval by required FEMA authorities.

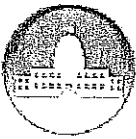
